On 13 February 2018, Dr Ruane (Director) loaned \$1,000,000 to the Company to be used for ongoing work relating to the LD Project.

The loan is on reasonable arm's length terms to the Company as it is unsecured with interest of 7.5% per annum payable quarterly in arrears.

After finalisation of the non-renounceable pro-rata rights issue on 23 August 2018, the Company repaid \$500,000 plus interest of the loan owing to Dr Ruane during the September 2018 quarter.

After 30 September 2018 the Company fully repaid the loan plus interest from Dr Ruane.
