Corporate Activities

Expenditure by Reward Minerals Limited ("Reward" or "the Company") during the June 2022 quarter was approximately \$324,000; a consequence of low-level activity at the Kumpupintil Lake and Officer Basin Projects.

Exploration and R&D activities were approximately \$228,000 - see Item 1.2(a) of the June Cashflow Report. Available cash at the end of the period was approximately \$2.4 million.

In accordance with ASX Listing Rule 5.3.5, \$12,000 was paid to related parties or their associates during the quarter.

Dr Michael Ruane is continuing as interim Managing Director / CEO pending appointment of a new CEO when a suitable candidate becomes available.

Kumpupintil Lake ("KP Lake") Potash Project Activities

Activities at KP Lake during the period primarily related to on-site engagement with the Martu Traditional Owners as part of the establishment of a new Cultural Heritage Management Plan ("CHMP") for the Project.

The first site visit was conducted between 29 June and 2 July 2022. A follow up meeting of Traditional Owners is scheduled for 8 to 14 August 2022.

The CHMP focuses on the preservation of Aboriginal Heritage and Cultural Values before, during and after the development and operation of the KP Lake Project. The CHMP will establish a framework for communication and monitoring of Company activities to ensure that Heritage and Culture Values are preserved.

Execution of an agreed CHMP is a requirement for Project development under the Aboriginal Heritage Act and the Environmental Approvals authorities.

Reward has had the privilege of association with the Martu custodians since 2006. Their knowledge of country and assistance in preparation of this CHMP is obviously essential and greatly appreciated by Reward. The Company also looks forward to employment of a significant number of Martu personnel at the Project when development commences.

Activities at the Project were seriously curtailed during the quarter by very heavy rainfall in early March. A significant program of earthworks has been undertaken to restore site access and functionality to both the KP Lake and Officer Basin Project sites.

R&D Activities

Reward continued research activities referred to in the March quarterly, aimed at recovery of SOP from brine resources existing in Australia and globally.

Further progress was made during the June quarter with the technology reaching the stage that the Company has engaged Patent Attorneys to draft a patent application

protecting the Intellectual Property globally. It is anticipated that the first Patent application will be lodged during the September quarter.

Reward believes that the technology has potential to significantly improve the viability of SOP recovery at the KP Lake Project and other SOP projects in WA. Following establishment of Flowsheet Mass Balance parameters for the new process, the Company will have a Scoping Study conducted by an independent engineering firm to assess the process operating parameters and economics.

Should a favourable outcome result, the Company's earlier PFS for KP Lake will be revisited incorporating the new technology and related operating parameters.

Officer Basin ("OB") Potash Project Activities

As mentioned above, activities at the OB Project were seriously curtailed during the quarter following >500 mm of rain in early March.

Access to the OB site has only recently been possible following repairs to the eastern Talawana Track and site tracks by the Reward crew

Activities only continued very late in the period, primarily with rehabilitation of drill sites and camp surrounds.




Figure 1. Kumpupintil Lake Potash Project (left) and Officer Basin Potash Project (right) Tenements

Further works at the OB site will require approval from JYAC (formerly WDLAC) and the Martu Traditional Owners to access and explore within the Warnturr and Timpirr Registered Heritage Site areas located within the OB tenement package (Figure 1).

The Company is currently seeking further discussions with JYAC on the access matter prior to planning any further exploration in the Officer Basin prospect area.

Mackay Range Farm-In Joint Venture ("JV")




Figure 2. Map of the MacKay Range Farm-In Joint Venture and Potash Rights Tenements

Late in 2019, Reward executed a Farm-In Exploration Joint Venture with FMG Resources Pty Ltd ("FMG") covering Reward's Exploration Licences 45/3285 and 45/4090 which form part of the Kumpupintil Lake Potash Project (Figure 2).

FMG retain the right to earn an 80% interest in the Reward tenements by expenditure of \$2 million over four years. Reward retains 100% Potash Rights over E45/3285 and E45/4090 and over the two adjoining FMG tenements E45/5362 and E45/5360. For further details of the Agreement see ASX Release 13 November 2019.

Works on the Farm-In to-date include helicopter VTEM geophysical survey, regolith mapping, ground gravity survey, passive seismic survey and surface sampling (soil, lag rock chip).

Activities by FMG during the quarter focused on completing the required heritage surveys in preparation for drilling which is scheduled for August 2022.

Reward is an ASX-listed advanced-stage sulphate of potash exploration and development company. Reward's flagship is its 100%-owned Kumpupintil Lake Potash Project, located east of Newman in north-western Western Australia. The Project hosts Australia's largest high-grade brine SOP deposit in a region with the highest evaporation rate. Key environmental approvals are in place and development can commence on completion of final feasibility studies, secondary regulatory approvals and achievement of funding.

Reward completed a detailed, conservative Pre-Feasibility Study which was updated with improved logistics in July 2018. An Indigenous Land Use Agreement is in place with the Martu people, traditional owners of the land upon which Kumpupintil Lake is situated.

Farm-in and Joint Venture Agreement with Fortescue Metals Group Ltd ("FMG") to earn an 80% joint venture interest ("JV interest") in the Tenements by spending \$2 million over four years, with a minimum expenditure obligation of \$400,000. Once the \$2 million expenditure threshold has been met, a Joint Venture will be established after which both parties will either contribute to expenditure in accordance with their respective JV interests or dilute. If a party's JV interest falls below 5%, that party's JV interest will be converted to a 1% net smelter return royalty to be paid over the first five years of commercial production.
- 2. Officer Basin Tenements are Registered under Kesli Chemicals Pty Ltd, which holds 100% beneficial interest in its Tenements on behalf of Reward Minerals Ltd.

In December 2021, an additional \$1 million was loaned to the Company by Dr M Ruane. The loan is unsecured, on reasonable arm's length terms and attracts interest at 7.5% per annum payable quarterly in arrears. The total facility of \$2.3 million is fully drawn down.
